Current Challenges and Opportunities in the European Union and neighbouring countries

A native of Romania, Dr. Ditiu is a physician and a public health expert, who has devoted her career to helping those affected by TB, especially people most vulnerable and living in communities heavily burdened by tuberculosis (TB). Over the last 5 years, Dr. Ditiu has been developing a clear identity for the Stop TB Partnership and ensuring a strong voice of the TB Community in the international arena. Dr. Ditiu began her international career with the WHO in January 2000 as a medical officer for TB in Albania, Kosovo and Macedonia within the dis-aster and preparedness unit of the WHO European Regional Office. In this role she worked in a very challenging environment and closely collaborated with main national stakeholders involved in TB care, including ministers of health, justice and develop-ment. In 2006 she was selected to be a medical of-ficer in the TB unit of the European Regional Office in Copenhagen. In January 2010 Dr. Ditiu joined the Stop TB Partnership Secretariat in Geneva to lead the TB REACH initiative - a Stop TB Partnership programme that awards grants up to US\$ 1 million for improving access to TB diagnosis and treatment and care for those that are most vulnerable.


