## TS OPTIONS

OSF embeds TS into grants provided to national or regional level organizations. ## TS OPTIONS

UNDP is providing TS in the next areas of HIV and TB responses as a division of labor with UNAIDS, UNFPA and the World Bank:

- stigma and discrimination including legal policy reform
- access to justice and rights
- HIV healthcare discrimination elimination
- HIV prevention among key populations (men who have sex with men, migrants, sex workers and transgender people)
- human rights

These include:

- Legal Environment Assessments
- Legal environments scans
- Strategic litigation

## WHO IS ELIGIBLE TO REQUEST TS

- Governments in the EECA Region
- Civil society organizations workin in HIV and\or TB areas in EECA region programming countries
- Regional KP Networks
- UNDP Country Offices

No programmes could be supported in some countries e.g. RUSSIA. Check with Regional team first.

## HOW TO REQUEST TS

Requests for TS from partners in EECA region can be received on an ongoing basis. Requests need to be submitted to the UNDP Focal points in the country offices where UNDP has HIV and Health programmes or with the Regional HIV Health and Development team for further consideration and subject to the availability of time and other resources. No special request form is required.

## TS OPTIONS

UNAIDS provides the strategic direction, advocacy, coordination and technical support (TS includes both technical assistance and capacity development) needed to catalyze and connect leadership from governments, the private sector and communities to deliver life-saving HIV services.

Technical support is provided by the UNAIDS staff and external consultants upon availability of funds in the following forms: oral and written consultations, analytical recommendations, review of documents and proposals, participation in advocacy activities etc.

Areas for TS at country and regional level:

- Evidence-based development and costing of the national strategic and action plan
- Expansion of specific programmes for KPs, PMTCT
- Improved access to affordable and quality assured ARV medicines and HIV diagnostic technologies
- Prevention of stigma and discrimination
- Systems strengthening, including the procurement and supply management, and the national monitoring and evaluation system
- Management and organizational development, specifically of coordinating bodies and civil society
- Operational research
- Resource mobilization, including proposal development

## WHO IS ELIGIBLE TO REQUEST TS

Government and Civil Society Organizations dealing with HIV and related issues in EECA region.

## HOW TO REQUEST TS

Official written request should be submitted to the UNAIDS RST or/and UNAIDS country office.

There are no any specific request form and deadlines.

## TS OPTIONS

Next TS could be available:

- Support in SRHR/HIV/STI programming among key populations, including young key populations
- Sharing best practices from the region

UNFPA support modality primarily envisages technical and expert assistance in the abovementioned areas.

The specific objective of BACKUP's CCM-related work is to help improve the CCM performance rating against Global Fund criteria. The achievement of this objective will be reflected in the improvement of the CCM classification according to the eligibility and performance assessment results. The targets of the CCM interventions are the improved governance and risk management of CCMs.

- Health Systems Strengthening ([more information online](#))

The overriding objective of BACKUP's HSS-related work is to support the selected countries in implementing HSS and gender-related interventions through Global Fund grants. The achievement of this objective will be assessed using a number of criteria, for example: the consideration of the Global Fund strategy's seven main approaches for building resilient and sustainable systems for health, a focus on integrated systems and services, the rationalisation of duplicated structures to increase sustainability, and country dialogue based more strongly around broader consensus processes.

- Grant Management ([more information online](#))

The overriding objective of BACKUP's work in the area of grant management is the reduction in twelve selected countries of operational programming and governance risks that the Global Fund considers as threatening the implementation of programmes. The achievement of this objective will be indicated through risk-related reports of the Global Fund or the PRs. BACKUP's technical support is targeted to PRs managing a large number of SRs and civil society PRs seeking to improve their grant management capacities. The grant management interventions should lead to improvements in the overall performance of the grant in terms of its output, outcome and impact targets and its absorption capacity.

Community, rights and gender are cross-cutting topics in all three intervention areas.

## WHO IS ELIGIBLE TO REQUEST TS

Government and civil society partners from the following countries: Kyrgyzstan, Uzbekistan.

## HOW TO REQUEST TS

The first step of the application process is a short (max.: one page) project outline summarising the name of the applying organisation, the identified needs, the activities proposed to address these needs, and the proposed timeframe.

Technical support can be provided in the following areas related to HIV:

Organizations representing communities, first of all PLWH, but also MSM, PWID, SW, TB/HIV, PLWH 50+ from the following 15 EECA countries: Poland, Lithuania, Latvia, Estonia, Ukraine, Moldova, Kazakhstan, Kyrgyzstan, Uzbekistan, Tajikistan, Azerbaijan, Belarus, Russia, Georgia and Armenia.

## HOW TO REQUEST TS

Response on the possibility to provide the requested TS will be provided within 5 days. If any additional information is needed, the TS manager will contact the applicant for further details. In case of a positive response, the support will be provided within the timeframe specified in the request. Thus, it is important to submit TS requests in advance for them not to be rejected because of the inability to meet the desired deadlines.

Technical support is available until October 31, 2018, up until termination of the Partnership for Equitable Access project. If new resources are available to provide TS for a wider circle of organizations and for a longer period of time, ECUO will inform about such options.

Technical support may be requested in Russian or in English.

## TS OPTIONS

Technical support may be provided to organizations working in the area of HIV among gay, other MSM and trans people in EECA for:

- assessment of general organizational capacity and development of NGO, drafting an organizational development plan, organizational development support
- financial management
- strategic planning
- assessment of the needs in HIV strategic information to implement current projects and the strategic plan
- organizing, preparing and conducting research studies, in particular developing study design, selecting research methods, etc.
- drafting funding requests for HIV projects among MSM and trans people
- introducing and implementing pre-exposure prophylaxis projects among MSM
- preparing and conducting workshops and working meetings related to human rights, in particular the right to health of gay and trans people
- training and support of community representatives for their effective engagement with international and national agencies coordinating the HIV response
- establishing and developing partnerships among NGOs, community activists and public officials

ECOM does not provide technical support in developing and implementing direct HIV services (outreach; development, publication and distribution of awareness-raising materials for clients; HIV counseling, referral to health institutions, HIV treatment, etc.), with an exception of pre-exposure prophylaxis programs.

## WHO IS ELIGIBLE TO REQUEST TS

First of all, technical support is provided to ECOM members as well as organizations involved in the ECOM projects. If technical support does not require urgent response and significant financial costs, such technical support may be requested by any NGO, governmental agency or health institution from EECA countries working with MSM and trans people whether or not it is a member of ECOM.

List of eligible countries: Azerbaijan, Armenia, Belarus, Georgia, Kazakhstan, Kyrgyzstan, Macedonia, Moldova, Russian Federation, Tajikistan, Ukraine and Estonia.

## WHO IS ELIGIBLE TO REQUEST TS

Representatives of NGOs and initiative community-based groups from all EECA countries could request technical support.

## HOW TO REQUEST TS

The applicant organization should send a TS request with the following information:

- Information about the organization requesting technical support
- Description of the problem, which is to be resolved through technical support
- Clear request with description of the problem, which is to be resolved through technical support requested and the expected results of such technical support
- What key and vulnerable populations will be covered with such technical support
- What other organizations have already provided technical support at such request (with a description of the results achieved)
- Deadline for providing the technical support

The Network will respond on TS availability within 10 business days. If the request is approved, the Network will appoint an expert to follow-up on the request and will undertake obligations to provide support in the scope and within the terms agreed with the organization requesting TS.

Requests could be submitted in Russian or English. There is no any formal TA request form to complete.

## TS OPTIONS

Within the Regional Civil Society and Community Support, Coordination and Communication Platform (EECA) project implementation, EHRA raises the awareness of civil society and communities in the region about the options of technical support within the Community, Rights and Gender (CRG) Technical Assistance Program of the Global Fund.

The goal of this program is providing short-term technical assistance to civil society and community-based organizations to meaningfully engage in the Global Fund model at the national level at any stage of the grant cycle, including during:

- Establishing and engaging in the country dialogue
- Funding request development
- Grant-making
- Grant implementation

The program currently does not support:

- Strengthening Country Coordinating Mechanisms
- Long-term capacity building of civil society organizations
- Funding request writing

Within one request, activities with a total budget of up to USD 25,000 may be supported.

## WHO IS ELIGIBLE TO REQUEST TS

Requests for technical support within the program may be submitted by NGOs and community-based organizations from the following EECA countries still eligible for the Global Fund HIV and/or TB funding or still implementing the grants: Albania, Armenia, Azerbaijan, Belarus, Georgia, Kazakhstan, Kosovo, Kyrgyzstan, Moldova, Montenegro, Romania (TB only), Serbia, Tajikistan, Turkmenistan (TB only), Ukraine and Uzbekistan.

## HOW TO REQUEST TS

All requests should be submitted using the official request form via email to [crpta@theglobalfund.org](mailto:crpta@theglobalfund.org).

The request should be reviewed within six weeks.
